The European Committee is the highest decision-making body of the European Coordination JECI-MIEC. That is why it is going to be the Coordination's most important assembly this year. We will talk about the previous year of the Coordination as well as plan the future one. We will also elect the new leadership of the Coordination. Therefore, it is crucial that as many Organizations as possible participate at the meeting.

It is important that your organization attends the European Committee 2014 in its entirety.

Quorum:

Please take into account that according to the Statutes Art. 10, for a session to be valid, the presence or representation of two-thirds of the full member organizations who have the right to vote will be requested, during the whole of the deliberations and for each vote.

Voting rights:

Please note that according to Art. 14,2 of the Statutes, the full member organizations who will not have paid their **membership fee** to the Coordination do not have the right to vote at the European Committee, as described in the Internal Rules.

Delegation of votes:

According to the Internal Rules Art. 11, the delegation of votes is possible under the following conditions:

- 1. The delegation of votes is allowed, either before or during the European Committee. It has to be introduced in writing to the European Team or to the Presidium of the European Committee.
- 2. An organization can delegate its right to vote to a member of the European Committee.

¹ We'll have space for maximum 30 persons. This is more than what we need to guarantee the participation of 1 delegate per movement. This means: Your movement can nominate 2 persons. But please understand that we can accept a second person from your movement definitely only after the deadline for inscription, because only then we know how many extra places we'll have.



- 3. If, during a session, a member entitled to vote has to leave the room, he/she will be asked to delegate his/her votes, either owns or delegated, and to tell the Presidium when he/she leaves and returns.
- 4. Each delegate cannot make use of more than one proxy-vote. So in case of delegation, one cannot make use of more than two votes at a time, i.e. the vote given to the organization and a delegated vote.
- 5. Each delegate must make use of all the votes he holds, either own or delegated to him, in a homogeneous manner.

In case you really cannot participate, please let us know as soon as possible, too, preferably with a short indication of the reasons.

We are looking forward to receiving your confirmation to participate at the European Committee 2014!
